SUPPORT PROSPECT HILL WITH A QUALIFIED CHARITABLE CONTRIBUTION

You can gift up to a maximum of \$100,000 per year from your IRA directly to a qualified charity such as Prospect Hill Cemetery without

having to pay income taxes on the funds.

Gifts of any value of \$100,000 or less are eligible for this benefit and you can feel good knowing that you are supporting and making a difference. This popular gift option is commonly called an IRA charitable rollover, but you may also see it referred to as a qualified charitable distribution, or QCD for short.

A charitable gift can be made year-round from your IRA account. To proceed, contact your IRA administrator (Fidelity, Schwab, Vanguard, Morgan Stanley, TD Ameritrade, etc.) to help get you started.

Please have the check made out to, "Prospect Hill Cemetery" and have it mailed to 2608 Lakeview Pkwy. Locust Grove, VA 22508. Ask your IRA administrator to include your name and address for acknowledgement purposes.

Alternatively, you can have your IRA administrator transfer the funds directly to Prospect Hill's Wells Fargo Advisors account. Just contact our treasurer, Rudy Becker at 540-308-5965 or email rbecker2004@yahoo.com.

UPDATE ON THE WATER BILL ISSUE aka CRIAC

Continued Good News – CRIAC relief program renewed for FY 2020

DC Water and Sewer Authority (DCWASA) renewed the amendment to its Customer Assistance Program which provides a significant one-year discount of the CRIAC fee for FY 2020 (October 1, 2020 thru September 30, 2021) to cemeteries and other non-profits. Organizations need to provide proof of nonprofit status and demonstrate need by proving that the CRIAC fee is at least 1 % of revenue after expenses. In addition, organizations would be required to install and maintain stormwater mitigation onsite or implement an alternative stormwater mitigation measure in the District, or in lieu accept a reduction in the discount to 72.3% if onsite mitigation is not possible.

PHC applied and was approved for the program. It received a credit to its account of \$10,665 for FY 2020.

We hope that the program for non-profits will continue to be renewed in future years.



100 YEARS AGO AT PROSPECT HILL

The following are excerpts from the book by Jean Bischof Crabill, "The Immigrants and their Cemetery: The Story of Prospect Hill, Chapter entitled "The Nineteen Twenties:"

"\$66,000 for Western Section. The amendment was reintroduced in the House District Committee of the 6th Congress by Mr. Reed on July 7, 1921, and it remained there until December 12, 1921, when the House finally passed it. The Senate accepted the amendment on January 20, 1922. Thus the western part of the Cemetery could now definitely be sold, though Congress had granted this right on August 5, 1890. The Board did not sell until forced to do so. It remained true to its principles! Three bids came in at once, the highest being from Mr. C. P. Knapp for \$66,000. It was accepted. The sale was approved in the Annual Meeting of Lot Owners on March 14, 1922. It comprised all land between V and Bryant Streets, NW."

"Mr. C. A. Bricked died November 7, 1921, after an accident while riding on a streetcar at Dupont Circle. He was 70 years of age, came to America in 1871, and was a member of the Board for 20 years, and treasurer for 8 years. He was also one of the founders and directors of the American Commercial and Savings Bank."

"Printed financial reports reveal cash assets of \$43,934 for 1921."

"Seven Members on the Board (1920). In harmony with the amended charter, seven members served on the Board (instead of eight) since 1920. 130 votes were cast in the 1921 election."

"The year 1921 constitutes the beginning of a good new custom – the writing of a brief general annual report by the president or secretary of the Board. Up to now there had been only chart-like dull financial accounts."

THE HERMANN WINKLER FAMILY

Hermann G. Winkler was born in Bunzlau, Germany, in 1888. After completing his basic education in Germany, he trained to become a printer. In 1911 he came to Washington, DC, to take a position as printer for the *Washington Journal*, the city's weekly German-American newspaper.

Gertrude Schillings was born in Cologne around 1887. Hermann had known her in Germany. A year or so after Hermann came to America she too left her native land. She and Hermann were married in Washington's St. Mary's Roman Catholic Church on January 8, 1913. The couple had two sons, Carl H., born May 2, 1914, and Hermann Martin, born November 9, 1915.

During his earliest years in Washington, Hermann lived at 536 20th Street, NW, and 306 H Street, NW. He became a naturalized citizen in 1917.

Within four years of beginning his work with the *Washington Journal*, Hermann had become its publisher and editor. The newspaper had become bankrupt; he purchased it and kept it in operation. In 1920 he bought the building at 710 6th Street, NW, which served as the business location of the *Journal* as well as a printshop handling both German and English printing. The Winkler family also lived at this location until the early 1930s, when they moved to 1434 Holly Street, NW.

Hermann took great pride in the fact that during his years as publisher and editor of the weekly, the *Journal* always met its deadlines and came out on schedule.

Hermann, Sr., was quite active in affairs of the German-American community. He founded a German Language School and served on the Board of Directors of the German Orphan Home for many years. Elected to the Board of Trustees of Prospect Hill Cemetery in 1919, he was named the Board's secretary in 1925. The last secretary to record minutes in German, he began using the English language in November 1925 in matters of the Board. He remained a most faithful and diligent secretary for nearly 30 years. In November 1953 he resigned from the Board because of ill health. The following spring, his son, H. Martin, was elected a Cemetery trustee; the following month he assumed his father's position of Board secretary.

Hermann died of cancer on October 5, 1954. His wife Gertrude lived until July 1968.

H. Martin had married in 1944. He and his wife, Jean, from New Haven, Connecticut, had three children: John Arthur, David and Jean. John Arthur lived only three years; he died on December 10, 1961. Jean, H. Martin's wife, died in August 1986.
