Your Board of Trustees strives to ensure that contributions received go to these goals. So we utilize all of your donations in the maintenance and preservation of our beloved DC Historic Landmark.

After the US Congress passed the Tax Cuts and Jobs Act of 2017 which included a large increase in the standard deduction, many non-profits felt that donations would decrease. Congress listened and included a provision in the CARES (Coronavirus Aid, Relief, and Economic Security) Act which allows all taxpayers to take a charitable deduction of up to \$300, even if they do not itemize. You might think that this is a small amount and would not make a difference. But what if all of our donors gave "just" \$300? Such support would have a huge impact.

For those who do itemize their deductions, the new law allows for cash contributions to qualified charities such as ours to be deducted up to 100% of your adjusted gross income for the 2020 calendar year.

We are not in the business of providing professional legal or financial advice, and you should consult with your own advisors to ascertain how these opportunities may complement your own personal, philanthropic and tax planning objectives.

So, we are appealing to you on a more personal basis. Let's not forget our own departed loved ones during this joyous holiday season when memories of happier days gone by keep filling our hearts and minds. Your donation to Prospect Hill is actually like a personal holiday present to your departed loved one.

UPDATE ON THE WATER BILL ISSUE aka CRIAC

Continued Good News - CRIAC relief program renewed for FY 2020 !

DC Water and Sewer Authority (DCWASA) renewed the amendment to its Customer Assistance Program which provides a significant one-year discount of the CRIAC fee for FY 2020 (October 1, 2020 thru September 31, 2021) to cemeteries and other non-profits. Organizations need to provide proof of nonprofit status and demonstrate need by proving that the CRIAC fee is at least 1 % of revenue after expenses. In addition, organizations would be required to install and maintain stormwater mitigation onsite or implement an alternative stormwater mitigation measure in the District, or in lieu accept a reduction in the discount to 72.3% if onsite mitigation is not possible.

PHC applied and was approved for the program. It will receive a credit to its account of \$10,665 over the next 12 months.

We hope that the program for non-profits will continue to be renewed in future years.
